COLUMBUS – The Asian-American Commerce Group (AACG), the Somali-American Chamber of Commerce (SACC) and the Hispanic Chamber of Columbus (HCC) recently signed a Memorandum of Understanding to work together in a coordinated effort to provide their respective members access to business opportunities as a collective, giving their membership more extensive services for their membership dues.

The working group was convened by the Ohio Chamber of Commerce and the U.S. Small Business Administration (SBA) in an effort to find ways that the various Chambers could partner to the benefit of their members. The group meets regularly once a quarter to develop ways to partner and collaborate. Chambers from across Ohio participate in the meetings.

In the Memorandum of Understanding:

- The Asian-American Commerce Group will incorporate the Hispanic-American and Somali-American IT companies under its umbrella and provide leadership when seeking IT contracting opportunities.
- The Somali-American Chamber of Commerce has an expertise in the area of transportation/logistics, with 7,000 members who are truckers. The SACC will incorporate Asian-American and Hispanic truckers under its umbrella for transportation and logistics contracting opportunities.
- The Hispanic Chamber of Columbus has a number of members in the franchising, business development and construction industries. As such, the HCC will incorporate Asian-American and Somali-American construction support under their organization to provide leadership for those seeking construction-related contracting opportunities.

“We are happy to convene local chambers of commerce to find ways that we can all work together for the betterment of our member companies,” said Ohio Chamber CEO Steve

Stivers. “When we can find ways to partner, like in the recently signed Memorandum of Understanding, everyone wins.”
