

# **OFFICIAL RULES – OSU FOOTBALL TICKETS SWEEPSTAKES**

These are the Official Rules for the Ohio State Football Tickets Sweepstakes (“Promotion”). The Promotion is administered by the Ohio Chamber of Commerce (“OCC”), 34 S. 3<sup>rd</sup> Street, Columbus, Ohio 43215.

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE THE ODDS OF WINNING.**

## **ELIGIBILITY**

The Promotion is open to legal residents of the fifty United States and the District of Columbia, except where prohibited, who: (a) are 18 years of age or have reached the age of majority in their jurisdiction of residence at the time of entry, whichever is greater, and (b) are legally able to work in the United States. No purchase is necessary.

Employees and agents of OCC and their immediate family members and/or those living in the same household of such persons, whether related or not, are not eligible to enter the Promotion.

## **HOW TO ENTER**

There are two methods to enter the Promotion. 1. Join the Ohio Chamber Action Network (Individual membership) 2. Send social media to your followers, friends, contacts mentioning the OCC Action Network and tag the OCC in the post.

Odds of winning a prize depend on the number of eligible entries received during the Promotion Period. Must be following OCC entered by 6pm on November 4, 2024.

Limit (1) entry in the Prize drawing, per person during the Promotion Period. Multiple entries will not be accepted.

Entry constitutes consent to participate in Promotions and for OCC to obtain, use, and transfer the entrant’s name, address, social media handle and other details for Promotion administration purposes. OCC will not be responsible for lost, incomplete, illegible, late, misdirected, stolen, or mutilated entries; technical or mechanical malfunctions; errors in the Official Rules, in any related ads or materials; or processing error. OCC can void the entry of any entrant who it believes has attempted to tamper with or impair Promotion administration, security, fairness, or proper play.

## **DRAWING**

Winner of the Prize will be selected in a random drawing on November 5, 2024, from all eligible Prize drawing entries received. Winners will be notified via email and/or a phone call. If a Prize winner is not eligible to win, or if the prize is not claimed within 48 hours, the prize will be forfeited and an alternate winner may be selected. Odds of winning depend on number of eligible entries received.

## **PRIZES**

Two tickets to the OSU Football game against Purdue.

Approximate Retail Value: \$500

Prize winners are responsible for any expenses incurred in connection with the prizes. No substitution or transfer of prizes is permitted, except that OCC reserves the right to substitute a prize of equal or greater value, in the event that an offered prize is unavailable. All federal, state and local taxes on prizes are the sole responsibility of the winner. Prize details not set forth herein are the sole discretion of OCC.

If requested, winners must execute and return an Affidavit of Eligibility and Liability Release within three days of notification. Failure to do so may result in disqualification, forfeiture, or award to alternate winner.

## **RELEASE**

By receipt of any prize, winner agrees to release and hold harmless OCC its officers, directors, employees, members, assigns and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Promotion or receipt or use or misuse of any prize.

## **GENERAL RULES**

Promotions are governed by and subject to the laws of the United States and the state of Ohio.

All federal, state and local laws and regulations apply. Void where prohibited by law. Prize Winner may receive an IRS 1099 form for the value of their prizes. By participating in a Promotion and/or accepting any prize, entrants grant OCC to use their name, likenesses, image and social media handle in connection with the Promotion for purposes of advertising, publicity and promotion purposes, without further compensation to the entrant, unless prohibited by law. Entrants agree to be bound by the Official Rules

and the decisions of the judges, which are final and binding on all matters relating to Promotions. OCC is not responsible for any typographical or other errors in the printing of the offer, administration of Promotions or the announcement of the prizes, or for lost, late, misdirected, damaged, incomplete or illegal entries.

OCC reserves the right at their sole discretion to disqualify any entrant found to be (a) tampering or attempting to tamper with the entry process or (b) violating the Official Rules.

## **DISPUTES/GOVERNING LAW**

Except where prohibited, as a condition of participating in Promotions, entrant agrees that all disputes that cannot be resolved between the parties, and all claims and causes of action arising out of or connected with the Promotion or any prize awarded, or the determination of winner shall be resolved individually, without resort to any form of class action. Further, in any such dispute, under no circumstances will entrant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, and entrant further waives all rights to have damages multiplied or increased.

All issues and questions rights and obligations of entrant in connection with Promotions shall be governed by, and construed in accordance with, the laws of Ohio, without giving effect to the conflict of laws rules thereof.
