# 136TH GENERAL ASSEMBLY

#### 1. WorkLearnOHIO

- Establish a public-private partnership connecting Ohio college students with in-state employers, expanding access to internships, externships, and co-ops.
- Blueprint reference: Education & Workforce, Pg. 29, Recommendation 2.5

### 2. Ohio Manufacturing Technologies Assistance Program

- Implement a grant program to help small and medium-sized manufacturers modernize machinery and facilities, overcoming financial and technological barriers.
- Blueprint reference: Innovation and Collaboration, Pg. 61, Recommendation 3.2

# 3. Strengthening Ohio's Energy Infrastructure

- Enhance energy reliability and affordability through improved electric and natural gas transmission while ensuring competitive bidding for increased power generation.

# 4. Expanding Access to Affordable Childcare

- Advance Ohio Chamber's Childcare Platform to lower costs, increase provider capacity, and develop a robust early childhood education workforce.

## 5. Implementation of the Ohio Taxpayer Protection Act

#### 6. Bolster Employer Protections in Recreational Marijuana Policies

#### 7. Improving Ohio's Legal Environment for Businesses

- Combat lawsuit abuse through oversight of third-party litigation financing, modernization of employment law poster compliance, and tightened restrictions on broad public nuisance claims against businesses.

## 8. Increasing Ohio's Housing Availability

- Implement Senate Select Committee on Housing recommendations, revise restrictive zoning laws, and incentivize local governments to support higher-density developments.

#### 9. Promotion of Computer Science and STEM Education

- Broaden access to computer science programs in K-12 education, invest in workforce pipeline initiatives, and incentivize tech-related college degrees to improve Ohio's ranking in STEM graduates.
